Primary Care Physician

Description

Vaden Health Center (“Vaden”), a principal unit of the Division of Student Affairs at Stanford University, is seeking a primary care physician for our Medical Services department.

Vaden is a AAAHC accredited freestanding, multidisciplinary ambulatory health care facility serving the 16,300 undergraduate, graduate, and professional students of Stanford University. The medical care team includes physicians, physician assistants, nurse practitioners, and nursing and clinical support staff. The health center also offers services in travel health, eating disorders, sports medicine, dermatology, optometry, physical therapy, counseling and psychological care, and health promotion.

Eligible candidates must be board certified in family medicine or internal medicine and must possess, or be fully eligible for, California licensure in the respective discipline. Primary responsibilities include providing direct medical care to patients, supervising NPs, PAs and residents, in addition to some on-call phone coverage for evenings and weekends. Strong skills in men’s and LGBTQIA health preferred. Experience in college health services or with young adult populations is ideal.

Compensation includes a comprehensive benefits package. Salary is commensurate with experience. The successful candidate will be appointed through Stanford University’s School of Medicine into the Clinician Educator track:

“Individuals appointed as **Clinical Instructors** will have completed their clinical training; this rank typically will be the first appointment for someone finishing that training. They should have demonstrated exceptional qualities and promise to become outstanding clinicians and clinical teachers. If these individuals have not had formal teaching experience, they should have demonstrated a commitment to develop the skills necessary for outstanding teaching. They must have demonstrated excellence or promise of excellence in a combination of clinical performance and clinical teaching appropriate to the programmatic need upon which the appointment will be based.”

"Individuals appointed as **Clinical Assistant Professors** should have demonstrated exceptional qualities and promise to become outstanding clinicians and clinical teachers. If these individuals have not had formal teaching experience, they should have demonstrated a commitment to develop the skills necessary for outstanding teaching. They must have demonstrated excellence or promise of excellence in a combination of clinical performance and clinical teaching appropriate to the programmatic need upon which the appointment will be based.”

"Appointment to the rank of **Clinical Associate Professor** in the Clinician Educator line will be considered for those who have demonstrated excellence in clinical care and clinical teaching. There should be evidence that candidates have attained regional recognition as superior

clinicians and clinical teachers. There should be evidence that the candidates will successfully fill the programmatic need for which the appointment is made and will make meritorious contributions to their discipline and to the School. Previous meritorious academic service on the faculty of a comparable medical school will be considered favorably when evaluating qualifications for initial appointment as Clinical Associate Professor."

"Appointment to the rank of **Clinical Professor** in the Clinician Educator line will be reserved for individuals who have demonstrated exceptional performance in clinical care and clinical teaching, and who are widely recognized as leaders in their field. There must be evidence that these individuals have attained national recognition as superior clinicians and clinical teachers, that they have demonstrated continuing excellence and progressive maturation as physicians and teachers, and that they will successfully fill the programmatic need for which the appointment is made and will continue to make outstanding contributions to their discipline and to the School. They may be recognized nationally as leaders of the health care system or of organizational change and measurement of health care systems."
