

## Liver Transplant – Valley Care Division of Gastroenterology and Hepatology Department of Medicine

The Division of Gastroenterology and Hepatology at Stanford University is actively recruiting a board-eligible Liver Transplant Faculty member to staff its growing inpatient service at Stanford Healthcare's Valleycare hospital in Pleasanton, California to complement Stanford Healthcare expansion efforts into the East Bay. This unique opportunity provides the hepatologist an opportunity to work closely with national leaders in academic gastroenterology and hepatology at Stanford and provide state-of-the-art care at a world renowned tertiary academic center.

The Division has been rapidly expanding in its clinical operations in the past few years. This role is created to ensure high quality care of patients admitted to the liver service at Valleycare. This Hepatologist will work with the existing Liver/Liver Transplant team of Faculty and Advanced Practice Providers currently on the service to expand the team's ability to care for patients on the liver service and to enhance the overall functional capacity of the team.

This Hepatologist will be joining the current Faculty covering this service, to allow for growth of the program and to provide time for both engagement in scholarly activities with members of the Division for current and future academic pursuit as well as educational activities that further the mission of the Division. The position will be approximately 6 months of consultative inpatient service a year including opportunities to round on the primary inpatient service in Palo Alto with outpatient clinics and endoscopy sessions to round out the clinical schedule.

We are particularly interested in individuals of under-represented minority status who are interested in pursuing a career in clinical gastroenterology and hepatology. As a member of the GI Division, you will be provided ample opportunities to focus on teaching, research, and other academic pursuits.
